**5.4. Severance:** If any provision contained in these terms and conditions is held to be illegal, invalid or unenforceable, it shall be severable, shall be deemed to be deleted from these terms and conditions and shall not affect the validity or enforceability of other provisions in these terms and conditions.

## **6. DISPUTE RESOLUTION**

Where any dispute arises in relation to the agreement or any matter arising under it, Uhurus and You will make genuine efforts to resolve the dispute by negotiation. Nothing in this Clause prevents either Uhurus or You from Applying to a court for urgent relief.
